# 1. Overall Job Purpose

The business analysis role is large, diverse and adaptable. The purpose is to provide independent research, advice, recommendations, conclusions and options to support all and any business decision at any and all levels of the organisation. They provide expert knowledge and have extensive experience, being able to understand the root cause of problems. BAs at the RSPCA are trusted and respected professionals who build relationships throughout the whole organisation.

The business analysts are able to support business functions through articulation of what they do and how they do it, They translate any requirements for change so they can be understood by the relevant audience, providing clarity and understanding so informed decisions can be made decisively.

Business Analysts perform a collaboration role in working with other technical specialists. These include support teams, solution architects, data architects, and programme / project managers. It is therefore essential that they adapt to the different industry standards these other professionals work within to reduce potential misunderstandings or confusion. These include but are not limited to; iTil, SOA, Agile, Prince 2, Waterfall, Togaf.

## 2. Principle Accountabilities

Investigation

• Carry out Enterprise wide investigation activities into the business environment to obtain a strong understanding of stakeholders, unfamiliar and complex systems and processes.

#### Analysis

- Provide expert business analysis knowledge and services to projects and programmes to support and enable business change and transformation activities.
- Carry out stakeholder analysis to identify, assess and manage all stakeholders and impacts.
- Facilitate the identification, documentation and quality assurance of business requirements (eliciting, writing and managing )through use cases, data flows, process modeling and change objectives throughout the project life cycle.
- Undertake modelling and mapping of business processes to include improvement and reengineering activity.
- Lead on Business Analysis assignments on medium (moderately complex) and large (complex) projects.
- Support business managers in making decisions regarding business change, innovation & transformation through feasibility assessments and by providing political neutral analysis, options and risk assessments.
- Provide business analysis services, which include gap analysis and product evaluation to allow the business to make strategic or tactical technology investment decisions and engage in tender and procurement processes where required.
- Contribute to solution design taking target environment and existing solutions into account to ensure maximum return on investment.

### Communication

- Provide clear verbal and / or written communications in the most appropriate manner for the stakeholders both internal and external. This can range from using business language and definitions to very detailed technical discussions.
- Provide graphical aids to support decision making, 'As Is' / 'To Be' comparisons and Impact Assessments.
- Undertake co-operative liaison and collaboration with technical specialists and business representatives to derive solutions that meet business needs, align with strategy and budgets and ensure effective delivery of a commission.

## Planning and Organising

• Plan and manage own workload aligned to the priorities and timeframes of projects & programmes

• Provide estimates to support planning.

### **Quality Assurance**

- Take responsibility for the creation, improvement and evolution of BA capability frameworks, which control the standards and quality of business analysis deliverables.
- Apply required standards and procedures to business analysis deliverables.
- Provide peer review of deliverables for Business Analyst colleagues.
- Ensure that any change meets all external compliance and legal obligations
