

RSPCA Furbo Camera Prize Draw

Terms & Conditions

1. The prize draw is open to all UK residents aged 18 years or over, except employees of the Promoter, their families, agents or any third party directly associated with administration of the prize draw.
2. The prize draw is free to enter and no purchase is necessary.
3. All entries must be submitted by completing an online application via <https://www.rspca.org.uk/adviceandwelfare/pets/dogs/kind/competition> and only one entry per person is permitted.
4. The opening date for entries is 8:00am on 17.6.2023. The closing date of the prize draw is 8pm on 24.9.2023. Entries received after this time will not be considered.
5. The Promoter accepts no responsibility for entries not successfully completed due to a technical fault [technical malfunction, computer hardware or software failure, satellite, network or server failure] of any kind.
6. Two winners will be chosen by random draw [performed by a computer process OR supervised by an independent person] on 2.10.2023.
7. The winners will receive a Furbo Dog Camera.
8. The winner will be notified by email (using details provided at entry) before 6 October 2023 and must provide a postal address to claim their prize. If a winner does not respond to the Promoter within 14 days of being notified by the Promoter, then the winner's prize will be forfeited and the Promoter will be entitled to select another winner in accordance with the process described above.
9. The prize will be sent to the winner by post within 14 days of being notified of their win.
10. The prize for the winner is non-exchangeable, non-transferable and no cash alternative is offered.

15. The Promoter reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.
